The Mayor/Local Liquor Commissioner is issuing the following rules for the said hearing in order to promote social distancing as required in Governor's Executive Orders and Disaster Proclamations.

- A. The City will set up a virtual meeting room, where the public can participate and listen to the meeting by call-in or by joining the meeting via video conference. All instructions and details about how to join will be available on the City Council hearing agenda at City Hall, and the on the City website.
- B. A web form will be available on the City's website which will let members of the public give comments on any aspect of the foregoing that they would like to comment upon and then space to type the comment. The form will ask for the person's name and city of residence.
- C. Information will be printed on the meeting agenda and prominently on the City's website about how to provide public comment, including a link to the web form. The information will be in substantially the following form: "NOTICE REGARDING MEETING AND PUBLIC TESTIMONY RULE MODIFICATION DUE TO COVID-19" pursuant to the recently amended Illinois Open Meetings Act allowing less than a quorum in-person attendance by members of a public body during the duration of the Gubernatorial Disaster Proclamation, all members of the West Peoria Liquor Commission will likely not be physically present for the July 15, 2020 Liquor Commission Hearing, but will instead be participating in the meeting through audio/video access using a virtual meeting platform.
- D. The instructions for addressing the Liquor Commission and Local Liquor Commissioner in this manner are provided as part of the agenda posting. Comments received between 11:00 a.m. and the adjournment of the hearing on July 15, 2020 at will be read aloud during the hearing. Comments will be read aloud in the order in which they were received. Comments will be limited to 2,700 characters each. Any comments unable to be read due to time limits will be published online as soon as practicable.
