



## 2019 City of West Peoria Residential Paint Program

### City of West Peoria, Illinois

Qualified property must be located within the City of West Peoria and program reimbursements are for  
**APPROVED EXTERIOR PAINTING OF HOME AND/OR ACCESSORY STRUCTURES ONLY.**

The Program will have a tiered payout based on the total verified expenditures as follows:  
**50% OF PAINT COSTS UP TO A MAXIMUM OF \$250 IF PAINT IS PURCHASED IN WEST PEORIA or**  
**30% OF PAINT COSTS UP TO A MAXIMUM OF \$250 IF PAINT IS PURCHASED OUTSIDE OF WEST PEORIA**

The City will accept only *one application per qualified property* between **May 1, 2019** and **April 30, 2020**. Program applications are received on a first- come first- served basis while funds are available. **Applications are allowed for 90 days from the date the application is received at City Hall and to the day all receipts are provided to City Hall.** All Program reimbursements of eligible costs are paid upon completion of the project; the availability of funds; and the approval of the Finance Committee and the City Council of the City of West Peoria. The City reserves the right to award program funds only to those projects it deems to be compliant with those projects that the City believes will stimulate the type of redevelopment that is in the best interests of the citizens of the City of West Peoria.
